Health Guarantee

"Companion/Pet" means the dog is sold for that purpose only and is not being sold with breeding rights.

- 1. Dog is a Labradoodle. Pedigree is correct and given at the time of sale. Dog is registerable with the CKC (Continental Kennel Club).
- 2. Dog will be free of hereditary crippling defects visible by 12 months of age. Dog will be replaced, provided dog is returned to seller, at the buyer's expense, within 14 days of discovery of such hereditary crippling defect. Buyer must provide documented proof of this hereditary defect by a licensed veterinarian. Seller will reserve the right to get a second opinion by Seller's licensed veterinarian. Buyer must also show proof of regular veterinarian pet care by a licensed veterinarian.

- 3. In order for the Health Guarantee to be honored, at the expense of the buyer, buyer must take dog to a licensed veterinarian within 72 hours of taking possession of dog for a health exam. Proof that the dog has been seen by a licensed veterinarian within this time frame must be sent to the seller within the 72 hour window.
- 4. Seller will accept returns of the dog at a full refund up to 7 days from original date of purchase. Arrangement and cost of transportation are the responsibility of the buyer.
- 5. If buyer chooses to return the dog within 7 days from original purchase date, dog must be returned in the same health/condition as they left seller with a health certificate from a licensed veterinarian.

NO OTHER WARRANTIES EXPRESSED OR IMPLIED

6. If the Buyer ever must give up ownership of the dog, for whatever reason, at whatever age, said dog must be returned to the seller, at the Buyer's expense, unless other agreements are made between the Seller and the Buyer.

Alteration Agreement

We care for our dogs and for the entire breed. Because of our concern, we make this agreement to help prevent pet overpopulation problems, and the propagation of serious inherited faults in the breed. Alteration will prevent many behavior problems in the male and has the added benefit of a longer and healthier life for both sexes. The purchase of this dog is for companionship only and is not for breeding. It is recommended to have this dog neutered or spayed. We recommend this be done between one year and 18 months. If Buyer chooses to neuter or spay their dog prior to one year of age Buyer understands that the Breeder cannot guarantee dogs hips, knees and elbows. There is scientific evidence that states early neutering and spaying reduces the hormone levels that are required to assist in full development of canine growth plates.

Buyer understands the CKC application to register is marked "Limited" to indicate that no offspring produced by this dog can be registered with the CKC. Buyer agrees that if they violate the Companion/Pet only agreement by breeding dog buyer will pay a fee of \$1000 to the Seller for full breeding rights. The owner will then file for a revision to the original CKC paperwork on their behalf. If breeding rights fee is not paid, Seller will file a grievance with the CKC to ensure no offspring from this dog can be registered.
